

# **BKV Connect Software License Agreement**

Brüel & Kjær Vibro GmbH, May 2023

#### Single Use License

Please read this hardware and software license agreement ("license") carefully before using BKV Connect.

By using BKV Connect (all variants), you are agreeing to be bound by the terms of this license, unless you return the BKV Connect as part of the return policy

If you do not agree to the terms of this license, do not use the BKV Connect. If you do not agree to the terms of the license, you may return the BKV Connect within the return period of fourteen (14) days to B&K Vibro or an authorized reseller/distributor where you obtained it for a refund.

#### 1. General

- A. The software (including Boot ROM code and other embedded software), documentation, interfaces, content and any data that came with your BKV Connect, whether on disk, in read only memory, on any other media or in any other form (collectively the "B&K Vibro Software") are licensed, not sold, to you by Brüel & Kjær Vibro GmbH ("B&K Vibro") for use only under the terms of this License. B&K Vibro retain ownership of the B&K Vibro Software itself and reserve all rights not expressly granted to you.
- B. B&K Vibro, at its discretion, may make available future updates to the B&K Vibro Software for your BKV Connect. The B&K Vibro Software updates, if any, may not necessarily include all existing software features or new features that B&K Vibro releases for newer or other models of BKV Connect. The terms of this License will govern any software upgrades provided by B&K Vibro that replace and/or supplement the original B&K Vibro Software on your BKV Connect unless such upgrade is accompanied by a separate license in which case the terms of that license will govern.

## 2. Permitted License Uses and Restrictions

A. Subject to the terms and conditions of this License, and against full and timely payment of license fees if so agreed between you and B&K Vibro, you are granted a limited non-exclusive license to use the B&K Vibro Software on a single B&K Vibro-branded or Customer-branded BKV Connect. You agree not to install, use or run the B&K Vibro Software on any non-B&K Vibro-provided device, or to enable others to do so. This License does not allow the B&K Vibro Software to exist on more than one device at a time, and you may not make the B&K Vibro Software available over a network where it could be used by multiple devices or multiple computers at the same time. This License grants you the rights to use B&K Vibro (proprietary) interfaces that are provided for third parties to extend BKV Connect to connect to external interfaces including external cloud systems or computers, as well as enabling 3<sup>rd</sup> party sensors to connect to BKV Connect. This License does not grant you any rights to use B&K Vibro intellectual property in the design, development, manufacture, licensing or distribution of third-party devices or third-party software applications and other intellectual property in the design, development, manufacture, licensing or distribution of third-party devices or third-party software applications of third-party devices and accessories.



- B. You may not, and you agree not to or enable others to, copy (except as expressly permitted by this License), decompile, reverse engineer, disassemble, attempt to derive the source code of, decrypt, modify, or create derivative works of the B&K Vibro Software or any part thereof (except as and only to the extent any foregoing restriction is prohibited by applicable law or to the extent as may be permitted by licensing terms governing use of open-source components that may be included with the B&K Vibro Software).
- C. Title and intellectual property rights in and to any content displayed by or accessed through the B&K Vibro Software belongs to the respective content owner. Such content may be protected by copyright or other intellectual property laws and treaties and may be subject to terms of use of the third party providing such content.
- D. You agree to use the B&K Vibro Software in compliance with all applicable laws, including local laws of the country or region in which you reside.
- E. The B&K Vibro Software may periodically check with B&K Vibro for updates to the B&K Vibro Software. If an update is available, the update may automatically download and install onto your BKV Connect. By using the B&K Vibro Software, you agree that B&K Vibro may download and install automatic updates onto your BKV Connect. You can request to opt out of automatic updates by contacting B&K Vibro or your distributor.

#### 3. Transfer

You may sell or otherwise dispose of BKV Connect to your direct customers provided that you do not grant any kind of separate or derivative rights to the B&K Vibro Software. The transfer must include (a) your BKV Connect and all of the B&K Vibro Software, including all its component parts, original media, printed materials and this License; (b) you do not retain any copies of the B&K Vibro Software, full or partial, including copies stored on a computer or other storage device; and (c) the party receiving the B&K Vibro Software reads and agrees to accept the terms and conditions of this License. All components of the B&K Vibro Software are provided as part of a bundle and may not be separated from the bundle and distributed as standalone applications. B&K Vibro Software provided with a B&K Vibro hardware product may not run on other models of B&K Vibro hardware.

## 4. Consent to Diagnostics and Updates

For diagnostic and product updates, you agree that B&K Vibro and its subsidiaries and agents may collect, maintain, process and use diagnostic, technical, usage and related information, including but not limited to unique system or hardware identifiers, information about your BKV Connect, system and application software, and peripherals, that is gathered periodically to provide and improve B&K Vibro's products and services, facilitate the provision of software updates, product support and other services to you (if any) related to the B&K Vibro Software, and to verify compliance with the terms of this License. B&K Vibro may use this information for the purposes described above. To enable B&K Vibro's partners and third party developers to improve their software, hardware and services designed for use with B&K Vibro products, B&K Vibro may also provide any such partner or third party developer with a subset of diagnostic information that is relevant to that partner's or developer's software, hardware and/or services, as long as the diagnostic information is in a form that does not identify the customer.



## 5. Termination.

This License is effective until terminated. Your rights under this License will terminate automatically or otherwise cease to be effective without notice from B&K Vibro if you fail to comply with any term(s) of this License. Upon the termination of this License, you shall cease all use of the B&K Vibro Software. Sections 2B, 4, 5, 6, 7, 8, 9, and 10 of this License shall survive any such termination.

#### 6. Warranties.

- A. See B&K Vibro Product limited warranty for general warranty terms and conditions for B&K Vibro products.
- B. You expressly acknowledge and agree that, to the extent permitted by applicable law, use of the BKV Connect and software is at your sole risk and that the entire risk as to satisfactory quality, performance, accuracy, and effort is with you.
- C. B&K Vibro does not warrant against interference with your enjoyment of the B&K Vibro software, that the functions contained in the B&K Vibro software will meet your requirements, that the operation of the B&K Vibro software will be uninterrupted or error-free, that defects in the B&K Vibro software will be corrected, or that the B&K Vibro software will be compatible or work with any third-party software or applications.

# 7. Limitation of Liability.

To the extent not prohibited by applicable law, in no event shall B&K Vibro be liable for personal injury, or any incidental, special, indirect or consequential damages whatsoever, including, without limitation, damages for loss of profits, corruption or loss of data, failure to transmit or receive any data, business interruption or any other commercial damages or losses, arising out of or related to your use or inability to use the B&K Vibro Software or any third party software or applications in conjunction with the B&K Vibro Software, however caused, regardless of the theory of liability (contract, tort or otherwise) and even if B&K Vibro has been advised of the possibility of such damages. in no event shall B&K Vibro's total liability to you for all damages (other than as may be required by applicable law) exceed the amount of fifty euros (50 Euros).

# 8. Controlling Law.

This License will be governed by and construed in accordance with the laws of Germany.

## 9. Complete Agreement.

This License constitutes the entire agreement between you and B&K Vibro relating to the B&K Vibro Software and supersedes all prior or contemporaneous understandings regarding such subject matter. No amendment to or modification of this License will be binding unless in writing and signed by B&K Vibro.



#### 10. Third Party Acknowledgements.

Portions of the B&K Vibro Software may utilize or include third party software and other copyrighted material. Acknowledgements, licensing terms and disclaimers for such material are contained in the electronic documentation for the B&K Vibro Software, and your use of such material is governed by their respective terms.
